Please note that the Ministry of Commerce, Government of Pakistan, in exercise of powers conferred by section 3 of the Trade Organizations Ordinance, 2007 (LXXI of 2007) has granted License # 07 date 3.04.2008, for a period of three years, to Rice Exporters Association of Pakistan, to work as an association representing persons engaged in the business of **RICE EXPORT**, on all Pakistan basis.

Please also note all REAP members are obliged to comply with the provisions of the Trade Organizations Ordinance, 2007 and the Rules framed there under read with the memorandum & Articles of Association of REAP, all the members were categorized into two classes, Associate class and Corporate class.

NOTE:

In order for a Representative of a Member to qualify to contest the elections for the seat on the Managing Committee, it shall be necessary that respective Member must have exported prescribed quantity of Rice in the Accounting Year immediately preceding the election. Provided that the minimum quantity prescribed for the said purpose is not less than two hundred and fifty metric tons for the relevant Accounting Year.
